She jokes: “The more complicated the better,” adding, “Unlike typical business litigation, family law cases often involve a broad spectrum of disciplines/issues, such as contracts, real estate, trusts, guardianships, conservatorships, probate, financial and sexual misconduct, adultery, pre- and postnuptial agreements, fraud and other torts, dissipation, domestic violence, and grandparent rights as well as typical divorce issues (such as equitable division, separate property, custody, child support, alimony, support, and attorney’s fees).”

Kresky Law is flexible as to forum and process; sometimes, arbitration may be preferred over court for privacy, efficiency, and speed. The firm does not operate in a vacuum. It works with a broad spectrum of highly qualified and competent experts—forensic accountants, economists, forensic psychologists, appraisers, guardian ad litem, evaluators, and others.

Kresky Law’s divorce cases generally involve financially successful individuals or their spouses. Complete financial transparency during discovery is critical. Adversaries often attempt to conceal assets and cover up reprehensible conduct. If that occurs, Kresky’s tenacity, knowledge of the law, and attention to detail come into play. She and her team do not hesitate to seek court assistance to obtain information being withheld or obscured.

To make sure every case receives the attention it needs and deserves, Kresky Law only takes on between 10 and 12 cases at a time.
